Non-Food Emergency (NFI) kits distribution to floods affected families in Colombo and Gampaha district

1. Background

Extreme weather conditions prevalent in May 2016 in Sri Lanka resulted in severe floods and landslides affecting 340,150 persons in 22 districts. This resulted in 84 deaths while 116 persons were missing. Over 500 houses were fully damaged and 3,793 houses were partially damaged while 237,240 persons were displaced from their homes. The districts of Colombo, Gampaha and Ratnapura were the most severely affected by the floods, while Kegalle district was affected by several landslides.

In response to this UN-Habitat partnered with SLRCS to assist floods affected people in Gampaha and Colombo district with provision of Non-Food Relief (NFI) Items as a component of "Emergency Shelter Relief for Flood Affected Families in Western Province, Sri Lanka" programme under CERF funding.

2. Objective of the project

Provide lifesaving assistance through distribution of NFI kits to the vulnerable flood affected returnee's families in Colombo and Gampaha districts

3. Number of Beneficiaries covered: 13,500 families

Colombo district – 6830 families Gampaha district – 6670 families

- 4. Project Duration 3 months
- 5. Total Grant amount US\$ 337,359

This will be granted in 3 instalments. First instalment is US\$ 168,679 (50%), Second instalment (40%) US\$ 134,944 & final instalment (10%) US\$ 33,736

7.1 Beneficiary Selection

Initial selection of Divisional Secretariat (DS) areas and number of beneficiaries from each DS area was decided by the UN- Habitat in their initial assessment in consultation with relevant Government Officers.

Once the agreement was signed between SLRCS and the UN-Habitat, SLRCS officers with the officers from UN-Habitat re-visited the Divisional Secretaries to reconfirm the intervention and to request their assistance to select most vulnerable people for the distribution. Because of these discussions, some changes were made in Kolonnawa DS division and Kelaniya DS division. Number of GN divisions covered from Kolonnawa DS division reduced from 10 to 5 to cover maximum number of beneficiaries in a GN division due to highly population in the said areas. We had to drop Kelaniya DS division as there was no requirement for the said items at this stage. Negotiations are progressing either to allocated the said quantities to Dompe DS division or to divide among other DS divisions in Gampaha District.

The final list confirmed by the relevant Divisional Secretaries are given below in table 02.

Based on the above list SLRCS staff and volunteers facilitated to finalize the list of beneficiaries who are eligible to receive the goods. Final selection was done by the Grama Niladhari of the respective GN Division.

7.2 Procurement of Goods

Following items were procured for the distribution

- 1. Impregnated mosquito nets two for each family 1 large and 1 medium
- 2. Bed sheets two for each family 1 double and 1 single

Procurement was carried out following SLRCS procurement procedures. Steps of procurement is given below;

- a. Advertise the tender document in Sunday Observer of 23rd October 2016
- b. Tender Opening on 09th November 2016
- c. Technical Evaluation Process; to recommend suitable bidders as per the given specification on 16th November 2016
- d. Finalization of suppliers at the tender board meeting on 22nd November 2016

7.3 Receipt of Goods

Goods were received to SLRCS warehouse at Katunayake from 29th November 2016 onwards. These items were physically inspected and verified by SLRCS internal auditor and the outside auditors hired to conduct the audit of this project.

8. Outcome and recommendations

8.1 Outcome

Improved Health Conditions of Beneficiaries

In any project of this nature, the accurate selection of the most deserving beneficiaries will be considered vital. Most of the time the procedure will involve challenges. In this operation, the SLRCS and UN – Habitat officers teamed up with relevant government authorities to select the needlest of the affected people effectively. As mentioned earlier, SLRCS and UN – Habitat staff re-visited the selected areas prior to confirming distribution which resulted in successful selections.

Successful selection of beneficiaries in turn, resulted in 13,500 vulnerable families receiving NFI kits in an effective and timely manner, which ultimately acted to improve health conditions of the beneficiaries.

8.2 Challenges

A strong demand for these NFI items was witnessed in almost all the distribution points. This created challenges for effective distribution as crowd control became difficult. This issue was further complicated as the government authorities seemed to take little interest in the distribution.

8.3 Recommendations

With reference to the above-mentioned outcomes and challenges, it could be analysed that the duration of the project would preferably have been longer. An adequate time period to complete the project would have eased the challenges and improved the selection process further.
